## **GREETINGS:**

In the name of the State of Maine you are hereby requested to notify and warn the voters of the Town of St. Albans in said County, qualified by law to vote in town affairs, to meet at the St. Albans Town Hall, 7 Water Street in said Town on the 23<sup>rd</sup> day of August A.D., 2022 at 6:00 o'clock in the evening to act on the following articles, to wit:

- Art. 1. To elect a Moderator by written ballot to preside at said meeting.
- Art. 2. To see if the town will vote to authorize the Board of Selectmen to transfer up to forty-five thousand dollars (\$45,000) from the Public Equipment Reserve Account to the General Ledger Fund for the purchase of a used 4WD single axle truck, with plow, wing, and sander.
- Art. 3. To see if the town will vote to authorize the Board of Selectmen to reimburse the General Ledger Fund from the ARPA Money Market Account for the purchase of two (2) AEDs and back-up batteries in the amount of \$4,149.95.
- Art. 4. To see if the Town will vote to authorize the Board of Selectmen and Town Manager to sign the 80/20 Agreement with MaineDOT for the replacement of the bridge on Webb Ridge Rd and obtain the necessary financing for the bridge replacement. Total Construction costs not to exceed \$1.4 million dollars.

The Registrar of Voters will be in session for the purpose of revising and correcting the list of voters and accepting registrations of any person eligible to vote on August 23, 2022 in the morning from 5:30 p.m. to 6:00 p.m. in the Town Hall.

A person who is not a registered voter of St. Albans may not vote at town meeting. You are hereby directed to serve this warrant by posting in a public and conspicuous place seven (7) days at least before the holding of said meeting.
