Motion by Todd Brown to approve the minutes of the Selectmen's meeting held on Monday, November 4, 2019. Seconded by Hiram Weymouth Vote: 3-0

New Business

a. 2020 BUDGET

Manager Fisher presented his work on the budget to date, a 4-year trend analysis of the budget, with trending completed on the public works section and data gathered for trend analysis for the Fire Department.

Budget Chairman O'Neil asked if the budget committee will receive the same updates as the Board of Selectmen. Manager Fisher assured Chairman O'Neil that information and updates will be provided to both the Board of Selectmen and all Budget Committee members.

Budget Chairman O'Neil asked if Manager Fisher would still be using former Manager Rhonda Stark's budget papers. Manager Fisher stated that he was going to use Rhonda's forms but would be embellishing them with additional paperwork.

Manager Fisher stated he expected to have a preliminary budget completed within 2-3 weeks. The Selectmen and the budget committee reviewed the meeting schedule. There were no changes proposed. manager Fisher briefly reviewed the requests for donations for the next budget year.

b. Abatement Request – Sandy Bussell – Map 20, Lot 7-1, Acc #374, Amount to be Abated: \$152.78 After a very brief discussion in which the Manager stated that the abatement request was recommended by the Town Assessor. *Motion by Todd Brown, second by Hiram Weymouth, to grant the abatement in the amount of \$152.78 Vote 3-0.*

and Manager Fisher agreed to study the situation further and provide options for the Board of Selectmen to consider.

- Manager Fisher requested permission to allow Denise Linderman to provide free Zumba classes at Town Hall twice per week. After a short discussion, Hiram Weymouth made a motion, seconded by Peter Denbow to allow Denise Linderman to use the facility rent-free for Zumba Class. Vote 3-0
