## Reports

- 7. Fire Department
  - Bubar Rd hydrant needs to be dug up to be inspected and possibly replaced. The department is in process of checking and inspecting all the hydrants. The Department was able to acquire 10 portable radios at \$100 saving per unit by finding a vendor. Chief Crocker indicated that once the radios are in and programmed, they are going to have the new vendor check the repeater on the mountain. It has been malfunctioning.
- 8. Public Works Department
  - Bruce reported vandalism at cemetery due to an accident on cemetery rd. Todd Patterson stone was damaged beyond repair. Wants to put Sterling out for sale, sell equipment separately. Bruce suggested that he would get additional information on value to set price before listing to sell. Town of Palmyra is interested in purchasing one of our sanders. Repairs this week on grader changed hoses. Looks like it may be leaking antifreeze. Replaced some cutting edgers.
  - Bonnie Lawrence stood up and asked what roads we had worked on and indicated that Nyes Corner Rd had not been touched with a grader lately.

- 10. Selectmen's Items. **Hiram reported on the transfer station MMSWA**. They haven't decided on which company will be running the facility.
  - Todd brought an email he received from former fire chief Jason Emery regarding the air packs for the fire department. The email indicated that the packs are still serviceable for 2 more years. Discussion with Fire Chief Crocker. Chief indicated that the company is out of business. The level of servicing available at this time would be spotty. There isn't any production of new parts, the company may not have the parts needed at time of a repair to fix the packs, possibly jeopardizing safety of fire fighters.
