Tammy Crocker called the meeting to order at 6:00 pm The pledge of allegiance was recited.

Public Comment

Laurel and Rex Martin, of 591 Todds Corner Road, expressed their serious concerns about their neighbor who lives at 582 Todds Corner Rd. According to Mr. and Mrs. Martin, there are dogs running loose all the time, dogs running onto on neighboring properties, one neighbor has complain house is poorly built, last week the property owner shot off over 100 rounds after 11 pm with a heavy caliber semi-automatic rifle, he runs the chainsaw at night, the property owner drives a vehicle with Indiana plates, he has chickens ad there is garbage and trash all over the yard. Hiram Weymouth suggested they call the State Police for disturbing the peace after ten P.M. Manager Fisher recommended they call ACO Joe Glidden when the dogs are running loose, he is a no-nonsense ACO and he gives one warning and then he issues a citation.

Manager Fisher said that he will notify the Code Officer concerning the trash/garbage violation.

Meeting Minutes

Hiram Weymouth motioned to approve the minutes for June 13, 2022, seconded by Tammy Crocker. All in Favor.

2022 Tax Commitment

Rebecca Adams, Town Assessor's Agent, provided the Select Board with three options, maintain the same millage rate of .01675 with an overlay of \$44,760.04, increase the millage rate to .01680 with an overlay of \$53,536.23, or increase the millage rate to .01690 with an overlay of \$71,088.60. Becky explained that the school district budget increased slightly, the County budget increased slightly, and the town budget increased slightly. This was offset by revenue sharing. When actual revenue sharing received exceeds the amount budgeted, the additional funds must be used to pay down the taxes in the next calendar year as operational revenue. In 2021, St Albans budgeted \$175,000 for revenue sharing and received \$271,000. The difference is \$96,000 and that amount has been added to the operational revenue and has helped to offset the budget increases.

Motion by Hiram Weymouth, seconded by Tammy Crocker to approve the millage at .01675, no change in the rate, with an overlay of \$44,760.04. All in Favor.

Ms Adams stated that tax bills cannot be mailed out yet due to a software issue with the TRIO software, which hasn't been updated by Harris Company to reflect the increase in Homestead reimbursement of 3%. Once that upgrade has been accomplished, we will be able to print and mail the tax invoices.
