To: Mindy Reiss, a resident of St. Albans,

Greetings: In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the Town of St. Albans in said County of Somerset and State qualified by law to vote in town affairs to meet at the St. Albans Town Hall, in said town, on Tuesday, June 13th, 2023 at 8:00 o'clock in the forenoon, then and there to act upon Article 1, and by secret ballot on Article 2 as set forth below, the polling hours therefore to be from 8:00 o'clock in the forenoon to 8:00 o'clock in the afternoon, then and there to act upon the following articles to wit:

Article 1. To elect a Moderator by written ballot to preside at said meeting.

Article 2. To choose one Selectman for a 21 Month Term, and two Budget Committee Members each for a 10 Month Term.

Voting will be done by secret ballot.







