Art 1. To elect a Moderator by written ballot to preside at said meeting.

Art 2. To see if the Town will vote to adopt the "Medical Cannabis Registered Caregiver Permitting Ordinance", an ordinance that will require a permit and regulations for premises where a Registered Medical Cannabis Caregiver will operate within St. Albans, as set forth in the full text available with the Town Clerk, or take any other action relative thereto.

SELECTMEN RECOMMENDS FAVORABLE ACTION

Art 3. To see if the Town will vote to authorize the Board of Selectmen to transfer up to \$20,000 from the Unassigned Fund Balance for additional funds towards 2025 paving and gravel.

Art 4. To see if the Town will vote to appropriate the sum of \$10,000 from the Unassigned Fund Balance for the purpose of adding to the Town's Contingency Account, said funds to be used for unforeseen or emergency expenses during the fiscal year 2025, or take any other action relative thereto.

Art 5. To see if the Town will vote to transfer \$20,000 from the Bridge Reserve account to the Special Road Work—Town Bridge account to be used on erosion control at Goodwin Bridge, located on Devil's Head Road.
